
Figure 1. Exports: first six months of 2016	2



# 2 EXPORTS DURING THE FIRST SIX MONTHS OF 2016

During the first six months of 2016, the exports of goods from Cordoba reached 4,373 million dollars. This figure represented 15% of Argentine exports in this period (**Figure1.**)Even though this value meant a fall of 0.36%, with regard to the same period , last year (**Chart1**,)the volume of exports increased 22.3% (**Chart2**.)





Figure 2. Export destinations of Cordoba. First six months of 2016

The major export destinations of the province were China, Brazil and Vietnam (Figure2.)

The 48% of exports were agricultural manufactured products, followed by primary products (38%) and industrial manufactured products (14%)(**Chart1**.)

The exports of primary products from Cordoba were concentrated in China. The 29% of these items were destined for this country(**Figure5**.) The agricultural manufactured products were destined for Vietnam and India (15% and 9% respectively)(**Figure7**.) Moreover, the exports of industrial manufactured products were mainly destined for Brazil (55%,) followed byThe United States (12%,)(**Figure9**.)





Figure 4. Primary products: export destinations of Cordoba. First six months of 2016




Figure 6. Agricultural manufactured products: export destinations of Cordoba. First six months of 2016




Figure 7. Top ten export destinations of AMP. First six months of 2016





Figure 8. Industrial manufactured products: export destinations of Cordoba. First six months of 2016

Figure 10. Participation in Cordoba exports per economic areas and selected countries. First six monthsof2016




Chart 3. Exports per economic areas and selected countries. First six months of 2016
